Meeting was called to order at 6:00 p.m. by Chairman Marcotte.

Public Hearing

Starvos Mendros - Recommends revisiting the compensation plan, perhaps by allowing commissioners to purchase their own insurance with a small subsidy.

Elaine Makas - Handed out a worksheet explaining what commissioners do, and another comparing wages and compensation for commissioners in various counties.

Mary Roussel, Auburn citizen - Stated her belief that the proposal by Elaine Makas is reasonable.

Heidi Brooks, State Representative-elect - Believes healthcare is an important piece of the compensation package and recommends that the elected commissioners receive fair compensation, especially regarding healthcare.

Ron Chicoine, County Commissioner-elect - Believes it is reasonable for commissioners to have health insurance, especially for those who really need it. He also noted that he is not planning on using the health insurance, and others may not as well, and this could lead to lower costs than anticipated.

Randall Greenwood, Chairman - Feels the public needs to know that after the last meeting, "I really felt like I was kicked, knocked down, and dragged across the floor." He explained some of the responsibilities of the commissioners and noted that the compensation package presented to the budget committee was carefully thought out. He asked the budget members to reconsider and support the proposal for single subscriber coverage and the compensation package.

Michael Dubois Judge of Probate - Stated that the Maine Constitution and Federal Constitution have an article that prohibits a legislative body from reducing the compensation of a judge while in office. He asked that the budget committee follow the law-that there not be a diminishment of the judge's compensation.

Joanna Said Register of Probate - Expressed her concerns regarding the Probate Department. She feels that the Register of Probate should be a full-time job. Noted that Androscoggin is the only county in Maine, in which it is a part-time job. Also stated that there are only two people working in Probate on a daily basis and that they are understaffed. Yet, the Probate's budget was cut about \$3,700 dollars. Ms. Said explained that when the budget is cut, consideration should be taken for employees' needs, and to ensure that services are being met. The justification of the budget cut as well as the cut to the Register of Probate's insurance should be addressed.

Michael Dubois Judge of Probate - Agrees with Joanna Said, and feels the Register of Probate is neglected, understaffed and underpaid. He asked that the budget committee take this information into consideration when making budget decisions.
