As you are aware we recently went out to bid for one (1) 2021 Ford Interceptor cruiser for the sheriff's office. The bid request was sent out to twelve (12) Ford dealerships. Three of the dealerships responded with bids.

We received bids from Rowe Ford Auburn with a bid of \$34,700, Quirk Auto Group had a bid of \$33,806.00 and Darling's Ford had a bid of \$33,757.00.

RE: Chevrolet Tahoe bid

Mr. Post,

As you are aware we recently went out to bid for four (4) 2021 Chevrolet Tahoe PPV cruisers for the sheriff's office. The bid request was sent out to fourteen Chevrolet dealerships. Three of the dealerships contacted Chief Deputy Gagne to let us know that they have no police Tahoe's available on their lots; that they can no longer order 2021 Tahoe PPVs and GM has not released pricing for the 2022 models. This means we would not be able to get these vehicles until sometime in 2022.

We did receive one bid from Colonial Municipal Group which is located in Plymouth, Massachusetts who we purchased two 2020 Chevrolet Tahoe's from last year. They have 2020 models available on their lot that would meet our needs. The cost is \$39,340.95 per vehicle.

I am recommending that the vehicle bid be awarded to Colonial Municipal Group.
