One is related to human resource issues that he has recently noticed and the other training involves risk mitigation of law enforcement personnel.

Commissioner Lary stated, "The Charter makes it clear that the board appoints committees."

Administrator Post stated that the Charter refers to "Commissioners creating a committee, they're talking about a committee of commissioners...It's not an outside committee...It doesn't preclude anybody else going ahead with other committees."

Continued discussion regarding the committee.

Motion: to call the question.

Ames-Michael 6-1 Opposed: Lary Motion: to support the Sheriff's request to form an exploratory committee.

Michael-Ames 6-1 Opposed: Lary

Commissioner Lary would like the minutes to reflect that, "that is not within the role of the sheriff per the charter, by my understanding, to form a committee and then expect us to bless that committee. It is the role of the commission and it's a violation of my rights and the rest of the rights of the commission whether they choose to or not."

## IX. DISCUSSION ITEMS

A. Inmate Vaccinations-Commissioner Madore stated that the administration was talking about vaccinating people/inmates 60 years and older in a month.

B. Indoor Gathering Rule-Discussion regarding Executive Order #35, March 26, 2021 through May 23, 2021: 50% of permitted occupancy, 5 persons per 1,000 sq. ft., or 50 persons, whichever is greatest.
