 - (3) Said Note is hereby sold and awarded to Androscoggin Bank
 - (4) Said not is designated as a qualified tax-exempt obligation of the County for purposes of Sectin 265(b)(3)(B)(ii) of the Internal Revenue Code 1986.
 - (5) All things heretofore done and all action heretofore taken by the County, its officers and agent in the authorization of said Note are hereby ratified, approved and confirmed, and the Treasurer and the Chair of the Board of Commissioners are each hereby authorized to take any and all action necessary or convenient to carry out the provision of this vote including delivering said Note against payment therefor.
