Motion: to not increase PSAP fees this year. (Two reasons:1st. If towns are to receive an increase, it should be early, as opposed to later. 2nd. We already have an additional revenue stream with the towns that came on board.) Christner-(no second) Motion fails

Communications Director Martin Fournier noted that they now have the 2020 Census numbers to calculate the new PSAP Fees.

Motion: to set PSAP Fees at 8%. Poirier-(no second) Motion fails

Motion: to accept the 5% PSAP Fee proposed. Ames-(no second) Motion fails

Motion: to set the PSAP Fees at 6.5%. Plourde-Poirier 3-2 Opposed: Christner, Ames Motion fails

Commissioner Ames asked if they could not come to an agreement, would it just start at the 2020 Census data.

Administrator/Sheriff Samson said they would have to send out a bill with just the current rates with the updated Census

Vice-Chair Kelly suggested to go forward with that plan if they cannot come to a consensus.

Motion: to allocate the 5%. Plourde-Ames 3-2 Opposed: Christner, Poirier Motion fails
